





## **ONE YEAR LIMITED WARRANTY**

**Warranty.** National Kitchen & Bath Cabinetry warrants that all cabinets sold by National Kitchen & Bath Cabinetry are free from defects in material and workmanship under normal use for a period of one year (1) limited warranty from the date of purchase. This warranty is only applicable to products used in residential applications and is not transferable to subsequent owners. This warranty shall become void if the cabinets are in any way modified, improperly assembled, installed or damaged prior to or during the installation. Furthermore, this warranty will not apply to cabinets damaged by misuse, neglect, abuse, exposure to moisture, exposure to extreme temperatures or the effects of normal wear and tear.

**Variations and Environmental Exposures Not Covered**. By purchasing the product, the original purchaser acknowledges that natural woods may vary in color, characteristics and exhibit subtle changes as they age. Sunlight, smoke, moisture, household cleaners and other environmental conditions may also affect the color match, or cause the materials to warp, split, or crack over time. These variations are considered to be the nature of the material in relation to their environmental exposure and are not covered under this warranty.

**Updated Product Lines.** National Kitchen & Bath Cabinetry periodically updates and makes changes to its product line and specifications. If a warranty claim is filed after a National Kitchen & Bath Cabinetry product becomes obsolete, National Kitchen & Bath Cabinetry reserves the right to alter specifications and material without obligation to make similar changes to products previously manufactured. National Kitchen & Bath Cabinetry will replace the part under warranty with a new part of the same style or with a similar style currently offered, but National Kitchen & Bath Cabinetry cannot guarantee that the finish of these replacements will exactly match the finish and appearance of the components in the residential application. This is due to the changes that occur during the woods natural aging process, affecting its color and grain.

**Disclaimers.** THIS WARRANTY IS THE EXCLUSIVE WARRANTY OF NATIONAL KICHEN & BATH CABINETRY AND IS IN LIEU OF AND NATIONAL KITCHEN & BATH CABINETRY DISCLAIMS ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

**Non-transferability of warranty.** National Kitchen & Bath Cabinetry's warranty is not transferable to end-users, including consumers and homeowners who purchase National Kitchen & Bath Cabinetry products through the original purchaser. Any and all end-user warranty claims must be handled through and by the original purchaser, which may independently provide warranties to the end-user. Where the original purchaser, through its independent warranty with and end-user, is liable for a claim that would otherwise have been covered by National Kitchen & Bath Cabinetry's warranty to the original purchaser but for its non-transferability.

**Submitting a Claim.** To obtain replacement(s) under this limited warranty, the original purchaser must contact the National Kitchen & Bath Cabinetry office or warehouse from which the product was purchased. A sales receipt or paid invoice as proof of purchase is required to obtain benefits from this warranty, dated no earlier than one year (1) from the date of warranty claim and (2) if the claim is from an end user, first contact your authorized National Kitchen & Bath Cabinetry dealer or distributor, who will arrange for inspection of the cabinet. A copy of the end-user's the original purchaser sales receipt is required, dated no earlier than one year (1) from the date of warranty claim.
